- 1. **Rental Period:** The Renter agrees to return the bounce house in the same condition as received, except for normal wear and tear, by the agreed-upon end time.
- 2. **Proper Use:** The bounce house must be used under adult supervision at all times. No food, drinks, shoes, or sharp objects are allowed inside.
- 3. **Weather Policy:** If weather conditions become unsafe (rain, strong winds, etc.), the bounce house must be deflated and not used.
- 4. **Damage Responsibility:** The Renter is responsible for any damage to the bounce house caused by misuse, negligence, or failure to follow rules.
- 5. **Indemnification:** The Renter agrees to indemnify and hold harmless the Rental Company from any claims, damages, injuries, or losses related to the use of the bounce house.
- 6. **Cancellation Policy:** Cancellations must be made at least _7__days in advance for a refund less the deposit amount (\$50.00)
- 7. Safety Rules:
- a. No flips, wrestling, rough housing or climbing on walls.
- b. No exceeding the maximum capacity limit, weight and height limit
- c. Adult supervision is always required.
- d. No sharp objects
- e. No food or drink
- f. No sliding head
- g. No watches or jewelry
- h. No shoes
- No hands or feet on netting
- j. Do not use it in windy conditions
- k. Do not touch any chords or fans that may be attached
